### **XIII. REPORT OF COUNTY MANAGER**

- The boiler in the court house is operational, it is warm at the court house and contrary to rumors, Spalding County will be open tomorrow.
- In my memo regarding the MLK parade there was an error. The memo stated January 30, the actual date of the parade will be Monday January 20 at 3 p.m. Commissioner Ray and Commissioner Johnson are planning to attend and will be riding on a fire truck or in the delegation with the Fire Department. Another email will be sent out reflecting the correct date. This is a non-candy parade.
- 2014 is ACCG's 100<sup>th</sup> Anniversary. In celebration of their Centennial Anniversary they have many projects and programs scheduled to celebrate. They have asked that we adopt a resolution supporting their Centennial Anniversary.

#### **XIV.REPORT OF COMMISSIONERS**

##### **Commissioner Miller**

- Wanted to know what progress has been made on the Vaughn School Road pot holes and getting a gate put up blocking the reservoir from trucks using the area for mud bogging.

County Manager Wilson advised that he had sent the request into the City and he would have to check to see what has been done. Mr. Wilson further stated that he had checked on the Covington Road and Public Works has been out and put gravel on the road and the plan was to go back out today because where people are entering Steele Road from Covington they are throwing the rocks up and they were going to put the gravel back on the roadbed there.

- Commissioner Miller stated that he had calls regarding Hwy 19 at the Ingles where there used to be a Yield sign, the sign was not put back up once the work was done and people are flying through that turn.
- He further commented that on Moose Lodge Road between 19-41 and Carver Road, there is another hole about 4 inches deep. This hole has been patched at least 3 times and the material being used is not holding up, we need to find another material that will be more durable.

- Commissioner Miller commented that he had visited the Voters Registration office today and I wanted to say that they have a real nice set up now. Terry and they have done a great job working on that location, it is really nice.

### **Commissioner Flowers-Taylor**

- Commissioner Flowers-Taylor stated that she wanted to commend Ms. Irma Lewis, Victim Services Representative, for her dedication and hard work in going above and beyond on Christmas day to assist someone in need. A patient that had been assaulted came into the hospital, it was obvious that the patient was in an abusive situation and could not return home. A call was made to Ms. Lewis and she left her family on Christmas day to help this person and I wanted to acknowledge the work that is being done.

- Stated that he looks forward to working with the Commissioners and with the citizens of Spalding County toward the betterment of our community. That includes all of Spalding County, Sunny Side, Orchard Hill and the City of Griffin.
- Expressed his thanks to the First Baptist church for opening up their Family Life Building this evening to serve the people in need.

## **Chairman Gardner**

- Thanked Commissioner Flowers-Taylor for her service as Chairman. He thanked her for stepping up to the plate and doing the job that you have done for the last 2 years.
- He is looking forward to working with all of the Commissioners as we continue to serve the Citizens of our community.
- Thanked everyone for their vote of confidence in electing him as Chairman. He stated that it is an honor to serve the citizens of this community and he thanked the staff stated he feels that we have an exceptional staff.
- Expressed concerns over the condition of the Dundee Mill location on High Falls Road. The property is not secure, it is an eye sore and basically the property is unsafe.
- He has had many positive comments regarding the resurfacing of local roads. He stated that citizens have called him regarding other concerns and ended by thanking him for the resurfacing of roads they have recently travelled.
- Thank the County Staff and Mr. Fortune for staying on top of the situation at the Holiday Pass subdivision. There was some damage done by the logging company and Mr. Crane and Mr. Fortune are working with the company to try to get the matter resolved.
