The hours for sex-offender registration are Monday through Friday from 8:30am and 4:30pm. No Appointment is needed; someone is available during these times. ANY change/update of required registration information must be done in person, by the offender.

If the offender is moving into Spalding from another county, state, etc., or if the offender is being released from state prison and will be living in Spalding County, that offender is required by O.C.G.A. 16-5-110 to remit \$25.00 at the time of their registration. This fee is imposed to cover the cost of publication of notice of conviction/release from confinement in the legal organ (newspaper) of this county Sex Offender Websites:
