

# Board of Commissioners – Special Called Meeting March 11, 2024, at 6:00 PM Room 108, Spalding County Annex Building MINUTES

The Spalding County Board of Commissioners held a Special Called Meeting on Monday, March 11, 2024, at 9:00 am in Room 108 of the Spalding County Annex Building, with Chairman Clay Davis presiding. Commissioners Rita Johnson and Ryan Bowlden were present for the meeting. Commissioner Gwen Flowers-Taylor and James Dutton were absent from the meeting. Also present were County Manager, Dr. Steve Ledbetter, Director of Accounting and Finance, Eria Dye, and Deputy County Clerk, Ragan Jones to record the minutes.

## I. OPENING (CALL TO ORDER)

The meeting was called to order by Chairman Clay W. Davis.

### III. PLEDGE TO FLAG

Commissioner Ryan Bowlden led the Pledge to the Flag.

Motion/Second by Bowlden/Johnson to amend the agenda to add Beck, Owen & Murray presentation for the County Attorney position and remove the Executive Session. Motion carried by a unanimous vote.

#### IV. AGENDA ITEMS

1. The Spalding County Board of Commissioners to hear presentations from perspective law firm, Beck, Owen & Murray, for County Attorney.

Mrs. Windham thanked the Board for scheduling this meeting around her prior obligations. She stated she has been honored to represent the county as County Attorney for 4 years, and highlighted that Beck, Owen, and Murray served as County Attorney for more than 60 years. Her firm serves as attorney for numerous governmental agencies in Spalding County and surrounding communities. Mrs. Windham stated her firm has positive relationships with Spalding County employees, and that is not easily duplicated. She mentioned her availability to the Board. She thanked the Board for her established relationships and hoped to continue to serve the Board of Commissioners as County Attorney.

Mrs. Windham responded, "No. Mr. David Penland joined the firm, and supports the legal needs of the county. He has come in and taken over some responsibilities."
