

Board of Commissioners – Regular Meeting August 5, 2024, 6:00 PM Room 108, Spalding County Annex Building After Agenda

The Spalding County Board of Commissioners held a Work Session on Monday, August 5, 2024, in Room 108 of the Spalding County Annex Building located at 119 E. Solomon Street, Griffin, Georgia beginning at 6:00 p.m. with Chairman Clay Davis presiding. Commissioners Rita Johnson, Gwen Flowers-Taylor, Ryan Bowlden, and James Dutton were present for the meeting. Also present were County Manager, Dr. Steve Ledbetter, County Attorney, Stephanie Windham, Director of Finance and Accounting, Erica Dye, and Deputy County Clerk, Ragan Jones to record the minutes.

VIII. REPORT OF COUNTY MANAGER

- During the last few years, we have searched for a deputy county manager. I'm happy to report this evening that Ms. Erica Dye was promoted last week to fill the role of Deputy County Manager. Initially in her role, she will oversee Administration, Finance, HR, IT, and Communications. Over the next few months, the plan is to expand her responsibilities.
- I am also happy to report the following hires:
 - o Citizen Engagement Specialist Dr. Cherryl Burks. This is her second week with the County
 - o Community Development Director who will start August 19th
 - o Senior Planner we now have several applications and will begin the interview process as our new Community Development Director takes on his role
 - o Grants Manager who will start this month
 - o New Fire Fighter training class is scheduled to graduate November 22nd

o I want to say thank you to the Board of Commissioners for the work performed over the last eight months with Evergreen Solutions, the consulting firm who completed the study that you reviewed to alleviate pay compression. Since your approval of the pay plan, our HR department receives more qualified applicants.

- Dante Handel (Associate Director of Governmental Affairs) with ACCG will provide an update on HB 581 – Property and Sales Tax Reform to our Board of Commissioners on August 29th at 6:00 pm.
- Chairman Davis and I will attend the ACCG Governmental Affairs team in Bartow County on August 7-8 to discuss several important issues ranging from property tax reform, mental health, public works bid threshold, truck weights, GDOTs Infrastructure Bank, LMIG funding, Solar Facilities and Local Government regulations, Electric Vehicle infrastructure, to elections. This is the first of two sessions ACCG will conduct in August. The second session is scheduled for August 21st and 22nd in Dougerty County.
- The firm conducting our Forensic audit continues to progress their work with the full cooperation of county staff. We anticipate the audit will be completed at the end of October.

IX. REPORT OF COMMISSIONERS

<u>Rita Johnson</u>

- Inquired about Charles Abbott & Associates; asked if this was on hold until the new Community Development Director started.

• Expressed heartfelt gratitude towards the gentleman involved in the award presentation for the life-saving award received today. She remarked on the remarkable nature of the award and extended her thanks to the fire department for their exceptional service.

James Dutton

- Spalding County is a great community to live in!

<u>Gwen Flowers-Taylor</u>

- Expressed gratitude towards the fire department for their diligent work. She emphasized that the fire department often doesn't receive due credit for their significant contributions to the community, as they are typically the first responders on the scene.
- Stated the importance of ensuring that the administrative staff reflects the diversity of the community in Spalding County.
- Noted that Mauldin and Jenkins discussed their concerns regarding the current training program, highlighting the amount of effort and funding dedicated to staff training and education. She expressed a desire to understand how these concerns will be addressed moving forward.
- Praised the fire department for their exceptional work and highlighted their program, "Praise and Preparedness." She emphasized the importance of this program, which educates church communities—especially the elderly—on CPR, AED usage, and the confidence to act in emergencies.
- Expressed hope that the chain of command would be documented in writing to provide clarity on its structure and function.
- Expressed concerns about the upcoming 2024 audit, fearing it might not go much smoother than the current one.
- Announced that there will be a public even on addiction this Friday, August 9th, at St. John Lutheran Church from 9:30 AM to 11:30 AM. The event will feature an authority on discussing addiction in the community. The talk will also cover available funding from opioid settlement litigation and provide information on opportunities for recovery groups.
