

#### Board of Commissioners – Extraordinary Session August 19, 2024, 6:00 PM Room 108, Spalding County Annex Building After Agenda

The Spalding County Board of Commissioners held an Extraordinary Session on Monday, August 19, 2024, in Room 108 of the Spalding County Annex Building located at 119 E. Solomon Street, Griffin, Georgia beginning at 6:00 p.m. with Chairman Clay Davis presiding. Commissioners Rita Johnson, Gwen Flowers-Taylor, Ryan Bowlden, and James Dutton were present for the meeting. Also present were County Manager, Dr. Steve Ledbetter, Deputy County Manager of Administration, Erica Dye, County Attorney, Stephanie Windham, and Deputy County Clerk, Ragan Jones to record the minutes.

#### I. OPENING (CALL TO ORDER)

The meeting was called to order by Chairman Clay W. Davis.

#### II. INVOCATION

Commissioner Gwen Flowers-Taylor delivered the Invocation.

#### III. PLEDGE TO THE FLAG

Commissioner James Dutton led the Pledge to the Flag.

#### IX. REPORT OF COUNTY MANAGER

The bridge on Moon Road over Wildcat Creek is currently under repair due to issues with water turbidity, which has caused instability around the piers beneath the bridge. As a result, the Georgia Department of Transportation (GDOT) has mandated the closure of the bridge.

Commissioner Flowers-Taylor inquired whether the County has the funds available to repair bridges.

Dr. Ledbetter responded by stating that the County has approximately \$1,000,000 allocated for all road-related expenses. The funds for repairing the bridge will come from this budget, which also covers pothole repairs and other road issues. He also mentioned that the bridge was included in the Georgia Department of Transportation's Off-System Bridge Replacement Program, with repairs initially scheduled for 2026.

Commissioner Flowers-Taylor asked about the likelihood of GDOT reimbursing the County for the bridge repairs.

Dr. Ledbetter stated that GDOT would not provide reimbursement.

✓ Jenkinsburg Road was closed several years ago due to the bridge and its weight limitations. Despite placing signs, including digital signs in both English and Spanish, tractor-trailers continue to use the road and get stuck at the bridge, requiring the dispatch of another wrecker. Commissioner Dutton inquired why the County is involved in the private transaction of dispatching the wrecker.

Dr. Ledbetter clarified the County does not pay for the wrecker service but is responsible for dispatching the wrecker through the Sheriff's Department.

Commissioner Dutton asked whether "No Thru Trucks" signs were in place and if citations were being issued to violators.

Dr. Ledbetter was unsure but expressed hope that citations were being issued, noting that Jenkinsburg Road, as well as Jackson Road, are both listed as "No Thru Truck" roads.

Commissioner Dutton pointed out the cost to repair these roads is significant and that the wear and tear are not caused by regular four-wheel vehicles.

Dr. Ledbetter mentioned one of the arguments from truck drivers is that their GPS systems direct them to use these roads to reach PNG.

Commissioner Dutton then inquired if it was possible to contact Google about the issue.

Dr. Ledbetter responded they had already reached out to every search engine by phone and email regarding the bridge being out and the "No Thru Trucks" designation, but problems persist.

Commissioner Dutton suggested the County should consider filing a complaint with Judge Thacker and Judge Cavanaugh.

Dr. Ledbetter agreed, noting it would be beneficial, especially to address the potholes concentrated on the eastern side of Jackson Road.

- ✓ TSPLOST resurfacing project is three-quarters complete for this year, covering 29.41 miles of resurfacing. Over a three-year period, the program is approaching 75 miles of resurfaced roads. Originally, the program aimed to resurface 100 miles over a five-year period, so it appears that there will be an opportunity to resurface additional miles beyond the initial goal.
